**** INITIAL **** next to the option you choose.

_____ Option 1 (\$12,000.00): All charges paid in full on or before the first day of class.

_____ Option 2 (\$12,100.00): Payment Plan I is available where payments are made in two installments; \$6100.00 is due on or before the first day of class, \$6000.00 due before the 9th week of training.

_____ Option 3 (\$12,100.00): Payment Plan II is available where payments are made in three installments \$4300.00 due on or before the first day of class, \$3900.00 due at midterm, and a final payment of \$3900.00 due at the 14th week of training.

_____ Option 4 (\$12,100.00): Payment Plan III is available where payments are made in four installments \$3400.00 due on or before the first day of class, \$3100.00 due by the 5th week of training, \$2900.00 due by the 9th week of training, and a final payment of \$2700.00 due by the 13th week of training.

_____ Option 5: In-house financing at 10% for 5years, first payment due 1month after graduating or leaving the institute. This option requires a down payment of \$6000.00 toward tuition. The student will also be required to pay for equipment, books, & housing by or on the first day of class. This option requires credit approval. If you have bad credit or no credit, **you MUST have a co-signer and your co-signer will have to have credit approval.** If you choose this option, you must fill out the application for credit.

WITHDRAWAL & REFUND POLICY

WITHDRAWAL- Students who wish to withdraw from the program, can do so at any time. The student must fill out a withdrawal form in the admissions office or notify the institute through certified mail. The institute will issue a refund according to the refund policy. If a student fails to attend class for two consecutive weeks without prior

arrangements, he/she will automatically be removed from the program and refunded according to the refund policy regardless of whether any written notice is received by the institute.

REFUNDS-Cancellation before the first class will result in a refund of all monies paid, with the exception of the \$100.00 registration fee. Withdrawal after class has begun, but before 60% completion of the program, will result in a prorated refund based on the number of hours completed. There will be no refund after completing 60% of the program. Refunds are calculated based on the last day of attendance and they will be issued within 30 days of that date.

RESPONSIBILITIES

STUDENT RESPONSIBILITY-The student agrees to comply with the code of conduct and the code of safety as outlined in the catalog. Students are also expected to attend all classes and to study diligently. If at any time the student feels he/she is falling behind, it is his/her responsibility to ask for help. It is understood that failure by the student to attend class regularly, study diligently, or to comply with the code of conduct and the code of safety as stated in the catalog, or as otherwise prescribed by the institute, now or in the future, verbally or in written form, can result in immediate suspension or expulsion. It will be at the discretion of the institute and the institute will not be responsible for the remaining portion of the course of instruction. INSTITUTE RESPONSIBILITY- The institute will provide the applicant with classroom space, space on the dive station, use of the recompression chamber, handouts, and instruction in the program indicated. All diving equipment and supplies will be available for purchase through the institute. Upon successful completion of the program and after meeting graduation requirements, the institute agrees to award the appropriate certification(s) and to provide assistance in locating employment. However, the institute does not guarantee employment. The institute reserves the right to reorganize the curriculum and to change or revise starting dates. If necessary, suitable substitutions in the curriculum may be made by the institute.

TENDER/DIVER PLACEMENT-The institute provides instruction on developing resumes and conducting interviews. The Institute will also post and/or announce any inquiries for divers/tenders. Students will also be provided with a list of potential employers, including names and addresses.
